KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made entered into this 8th day of September year 2014 by and between the Department of Science & Technology, represented by its Regional Director ANTHONY C. SALES, Ph.D., CESO III hereinafter referred to as the party of the FIRST PART, and Davao Food Safety Team, Inc. hereinafter referred to as the party of the SECOND PART.

WITNESSETH

- 1) That the party of the Second Part shall provide:

**Food Safety Services in any of the following depending on the needs of the firm:
 (Good for 18 Firms Engagement @ Php 10,500.00/firm)**

1.) GMP Training for the food processing and service industry
 - at least 2 competent resource persons, training shall be comprehensive to include at least 10 relevant topics, shall include a soft copy and hard copy of the materials, shall provide all the necessary training materials

2.) GMP Assesment
 - shall have at least 2 competent resource persons, shall have site visit and ocular inspection of the facilities and area, shall include discussions of AO 153/AO 21 documentation review and interviews, shall include a comprehensive report on findings.

3.) Plant Layout Consultancy
 - shall deploy at least 2 competent experts, shall have a site visit and ocular inspection of facilities and area, shall include discussions on AO 153/AO 21, shall have comprehensive consultation with customer after site visit, shall provide final plant layout to the customer.
- 2) That the party of the First Part shall pay the Second Part in Philippine Currency the sum of PESOS: One Hundred Eighty Nine Thousand Pesos Only (Php 189,000.00) for the work.
- 3) This contract for furnishing services for the above-mentioned work shall remain in force and effect until work shall have been completed, effective upon acknowledgement hereof by the part of the Second Part.
- 4) That all laws, rules and regulations for government contracts including "force majeure cases" apply thereof.

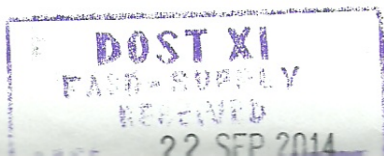
