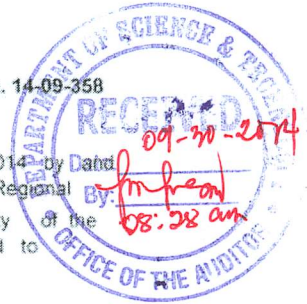

THIS AGREEMENT made entered into this 9th day of September year 2014 by and between the Department of Science & Technology, represented by its Regional Director ANTHONY C. SALES, Ph.D., CESO III hereinafter referred to as the party of the FIRST PART and Summit Consultancy and Research Services hereinafter referred to as the party of the SECOND PART

WITNESSETH

- 1) That the party of the Second Part shall provide

(a) Twenty five percent (25%) or Eighty Seven Thousand Five Hundred Pesos (Php 87,500.00) upon signing of this contract (b) Twenty five percent (25%) or Eighty Seven Thousand Five Hundred Pesos (Php 87,500.00) upon the submission of three (3) sets of inception report. (c) Twenty five percent (25%) or Eighty Seven Thousand Five Hundred Pesos (Php 87,500.00) upon the submission of three (3) sets of progress report and (d) Twenty five percent (25%) or Eighty Seven Thousand Five Hundred Pesos (Php 87,500.00) upon the submission of three (3) CD and printed copies of the final report and three (3) CD and printed copies of the industry report

- 2) That the party of the First Part shall pay the Second Part in Philippine Currency the sum of PESOS Three Hundred Fifty Thousand Pesos Only (Php 350,000.00) for the work.
- 3) This contract for furnishing services for the above-mentioned work shall remain in force and effect until work shall have been completed, effective upon acknowledgement hereof by the part of the Second Part
- 4) That all laws, rules and regulations for government contracts including "force majeure cases" apply thereof

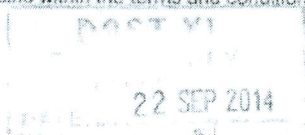
